

Senior FDA and USDA Alum David Goldman joins Food & Ag Consulting Firm Groundswell Strategy

With more than 30 years of experience including as a senior leader in public health at both the Food and Drug Administration and the United States Department of Agriculture, Dr. Goldman will serve as Groundswell's Senior Advisor for Public Health, providing strategic guidance to clients on the full spectrum of medical and public health issues across food, dietary supplements, and cosmetic products.

Trained as a medical epidemiologist, Dr. Goldman is a board-certified physician in preventive medicine and public health. He served most recently as Chief Medical Officer in FDA's Office of Food Policy and Response where he led the agency on issues related to food safety including strategic response to outbreak and recall events. In that role, he chaired the Center for Food Safety and Applied Nutrition (CFSAN) Health Hazard Evaluation Board, which evaluates the human health effects of physical, microbiological, chemical, or radiological contamination of food and cosmetic products. He also played a pivotal role in continuing to advance the agency's work to improve recall efforts by cochairing the Strategic Coordinated Oversight of Recall Execution (SCORE) team.

Prior to joining FDA, Dr. Goldman was Chief Medical Officer of USDA's Food Safety and Inspection Service where he was responsible for occupational health issues related to chemical and biological exposures, as well as for providing medical expertise on emerging food safety issues. He was Assistant Administrator for FSIS's Office of Public Health Science from November 2004 through May 2018, leading a staff of 300 that provided the scientific foundation for FSIS policies, conducted microbial risk assessments, led outbreak investigations and executed a national sampling program of meat and poultry products.

Dr. Goldman was a member of the Commissioned Corps of the U.S. Public Health Service since February 2002, retiring in August 2022 as Assistant Surgeon General with the rank of Rear Admiral. He spent 10 years in the U.S. Army Medical

Corps, practicing both family medicine and preventive medicine before holding multiple roles with the Virginia Department of Health. Dr. Goldman received his Bachelor of Arts from the University of Virginia, his Doctor of Medicine from the University of Virginia. He holds a Master of Public Health in Epidemiology from the University of Washington.
